UNDERSTANDING THE LAWS OF MOTION

THE FUNDAMENTAL LAWS

THE LAWS OF MOTION, FORMULATED BY SIR ISAAC NEWTON, ARE FOUNDATIONAL TO CLASSICAL MECHANICS. THIS MEANS THAT WHEN ONE BODY EXERTS A FORCE ON ANOTHER, THE SECOND BODY EXERTS A FORCE OF EQUAL MAGNITUDE IN THE OPPOSITE DIRECTION. THIS PRINCIPLE IS EVIDENT IN COUNTLESS REAL-WORLD APPLICATIONS, SUCH AS ROCKET PROPULSION AND SWIMMING.

APPLICATIONS OF MOTION LAWS

THE NATURE OF ENERGY AND THERMODYNAMICS

KEY CONCEPTS OF THERMODYNAMICS
