INTRODUCTION TO ELECTROMAGNETISM

UNDERSTANDING OPTICS

THIS UNDERSTANDING IS CRUCIAL FOR DESIGNING LENSES AND OPTICAL INSTRUMENTS.

OPTICAL INSTRUMENTS
