TYPES OF LINEAR PHYSICS EQUATIONS

KINEMATIC EQUATIONS

$$D = V_0T + 0.5AT^2$$

OHM'S LAW

IN ELECTRICITY, OHM'S LAW IS A LINEAR EQUATION THAT RELATES VOLTAGE (V), CURRENT (I), AND RESISTANCE (R):

$$V = IR$$

THIS EQUATION INDICATES THAT VOLTAGE IS DIRECTLY PROPORTIONAL TO CURRENT, WITH RESISTANCE BEING THE CONSTANT OF PROPORTIONALITY.

HOOKE'S LAW

IN MATERIALS SCIENCE, HOOKE'S LAW DESCRIBES THE LINEAR RELATIONSHIP BETWEEN THE FORCE APPLIED TO A SPRING AND THE DISPLACEMENT (X) IT CAUSES:

$$F = kx$$

HERE, ' F ' IS THE FORCE, ' k ' IS THE SPRING CONSTANT, AND ' x ' IS THE DISPLACEMENT FROM THE EQUILIBRIUM POSITION.

APPLICATIONS OF LINEAR PHYSICS EQUATIONS
