KINEMATIC EQUATIONS

FOR ONE-DIMENSIONAL MOTION WITH CONSTANT ACCELERATION, THE FOLLOWING KINEMATIC EQUATIONS ARE CRITICAL:

- $v = v_0 + at$
- $s = v_0t + (1/2)at^2$
- $v^2 = v_0^2 + 2as$

UNDERSTANDING THESE EQUATIONS ALLOWS STUDENTS TO SOLVE PROBLEMS RELATED TO THE MOTION OF OBJECTS, SUCH AS CALCULATING DISTANCE TRAVELED, FINAL VELOCITY, AND TIME OF TRAVEL.

ESSENTIAL EQUATIONS IN ELECTRICITY AND MAGNETISM

ELECTRICITY AND MAGNETISM ARE KEY COMPONENTS OF PHYSICS 211, ENCOMPASSING THE BEHAVIOR OF ELECTRIC CHARGES AND MAGNETIC FIELDS. THE PHYSICS 211 FORMULA SHEET CONTAINS SEVERAL ESSENTIAL EQUATIONS THAT AID IN UNDERSTANDING THESE CONCEPTS.

- $F = k (|q_1 q_2|/r^2)$, WHERE F IS THE FORCE, k IS COULOMB'S CONSTANT, q_1 AND q_2 ARE THE MAGNITUDES OF THE CHARGES, AND r IS THE DISTANCE BETWEEN THE CHARGES.

THIS FORMULA IS VITAL FOR SOLVING PROBLEMS INVOLVING ELECTRIC FORCES AND FIELDS.

PRACTICAL APPLICATIONS OF THE FORMULA SHEET
