He reasoned that this angle was the same as the angle subtended by the arc between Alexandria and Syene at the Earth's center. Knowing the distance between Alexandria and Syene, which he estimated to be about 5,000 stadia (a unit of length that varied, but he likely used the Egyptian royal cubit), he could then calculate the Earth's total circumference by multiplying this distance by the ratio of the full circle (360 degrees) to the observed angle (7.2 degrees). His calculation yielded a circumference remarkably close to the actual value, suggesting a radius of approximately 6,300 kilometers. This method, relying solely on geometry and observation, is a testament to the power of scientific inquiry.

The Physics of Gravity and the Earth's Radius
