### THE LITTLE ALBERT EXPERIMENT

CONDUCTED BY JOHN B. WATSON AND ROSALIE RAYNER IN 1920, THE LITTLE ALBERT EXPERIMENT DEMONSTRATED CLASSICAL CONDITIONING. A BABY NAMED ALBERT WAS CONDITIONED TO FEAR A WHITE RAT BY ASSOCIATING IT WITH LOUD, FRIGHTENING NOISES. THIS CASE STUDY RAISED ETHICAL QUESTIONS ABOUT PSYCHOLOGICAL RESEARCH AND THE TREATMENT OF SUBJECTS.

### THE CASE OF ANNA O.

ANNA O., TREATED BY SIGMUND FREUD AND JOSEPH BREUER, IS OFTEN CITED IN DISCUSSIONS OF PSYCHOANALYSIS. HER CASE ILLUSTRATED THE IMPORTANCE OF TALKING THERAPY AND THE CONCEPT OF REPRESSED MEMORIES. ANNA'S EXPERIENCES LAID THE GROUNDWORK FOR FREUD'S THEORIES ON THE UNCONSCIOUS MIND AND HYSTERIA.
