OVERVIEW OF THE BOARD OF PSYCHOLOGY OREGON

THE BOARD OF PSYCHOLOGY IN OREGON WAS ESTABLISHED TO PROTECT THE PUBLIC BY REGULATING THE PRACTICE OF PSYCHOLOGY THROUGH LICENSING, SETTING STANDARDS FOR PRACTICE, AND ENFORCING COMPLIANCE WITH ETHICAL GUIDELINES. THIS BOARD PLAYS A PIVOTAL ROLE IN ENSURING THAT MENTAL HEALTH PROFESSIONALS ARE QUALIFIED AND COMPETENT TO PROVIDE PSYCHOLOGICAL SERVICES TO THE RESIDENTS OF OREGON. THE BOARD IS COMPOSED OF MEMBERS WHO ARE LICENSED PSYCHOLOGISTS, AS WELL AS PUBLIC MEMBERS WHO REPRESENT THE INTERESTS OF THE COMMUNITY.

THE PRIMARY FUNCTIONS OF THE BOARD OF PSYCHOLOGY INCLUDE:

- ISSUING LICENSES TO QUALIFIED APPLICANTS.
- SETTING AND ENFORCING STANDARDS FOR THE PRACTICE OF PSYCHOLOGY.
- PROVIDING RESOURCES AND GUIDANCE TO BOTH PRACTITIONERS AND THE PUBLIC.
- INVESTIGATING COMPLAINTS AGAINST LICENSED PSYCHOLOGISTS.
- FACILITATING CONTINUING EDUCATION OPPORTUNITIES FOR LICENSED PSYCHOLOGISTS.

THESE FUNCTIONS ARE CRUCIAL FOR MAINTAINING THE INTEGRITY OF THE MENTAL HEALTH PROFESSION AND ENSURING THAT CLIENTS RECEIVE HIGH-QUALITY CARE.

LICENSING PROCESS FOR PSYCHOLOGISTS

THE LICENSING PROCESS FOR PSYCHOLOGISTS IN OREGON IS A RIGOROUS JOURNEY DESIGNED TO ENSURE THAT ONLY THOSE WITH THE APPROPRIATE EDUCATION AND TRAINING CAN PRACTICE. TO BECOME A LICENSED PSYCHOLOGIST IN OREGON, CANDIDATES MUST MEET SEVERAL REQUIREMENTS OUTLINED BY THE BOARD OF PSYCHOLOGY.

EDUCATIONAL REQUIREMENTS

FIRST AND FOREMOST, CANDIDATES MUST OBTAIN A DOCTORAL DEGREE IN PSYCHOLOGY FROM AN ACCREDITED INSTITUTION. THIS DEGREE TYPICALLY INVOLVES EXTENSIVE COURSEWORK, SUPERVISED CLINICAL TRAINING, AND A DISSERTATION. THE BOARD RECOGNIZES SEVERAL TYPES OF DOCTORAL DEGREES, INCLUDING PSY.D. AND PH.D. IN PSYCHOLOGY.

EXAMINATION REQUIREMENTS

AFTER COMPLETING THEIR EDUCATIONAL REQUIREMENTS, ASPIRING PSYCHOLOGISTS MUST PASS THE EXAMINATION FOR PROFESSIONAL PRACTICE IN PSYCHOLOGY (EPPP), WHICH ASSESSES THEIR KNOWLEDGE AND COMPETENCE IN VARIOUS PSYCHOLOGICAL DOMAINS. IN ADDITION TO THE EPPP, CANDIDATES MAY ALSO NEED TO PASS A STATE-SPECIFIC EXAM THAT FOCUSES ON OREGON LAWS AND REGULATIONS GOVERNING THE PRACTICE OF PSYCHOLOGY.

APPLICATION PROCESS

ONCE THE EDUCATIONAL AND EXAMINATION REQUIREMENTS ARE FULFILLED, CANDIDATES CAN SUBMIT THEIR APPLICATION FOR LICENSURE TO THE BOARD OF PSYCHOLOGY. THIS APPLICATION TYPICALLY INCLUDES:

- PROOF OF EDUCATION AND TRAINING.
- VERIFICATION OF SUPERVISED EXPERIENCE.
- RESULTS OF THE EPPP AND STATE EXAM.
- BACKGROUND CHECK AND ANY APPLICABLE FEES.

THE BOARD REVIEWS APPLICATIONS THOROUGHLY, ENSURING THAT ALL CANDIDATES MEET THE REQUIRED STANDARDS BEFORE GRANTING LICENSURE.

CONTINUING EDUCATION REQUIREMENTS

ONCE LICENSED, PSYCHOLOGISTS ARE NOT DONE WITH THEIR EDUCATION. THE BOARD OF PSYCHOLOGY MANDATES CONTINUING EDUCATION (CE) TO ENSURE THAT PRACTITIONERS STAY CURRENT WITH DEVELOPMENTS IN THE FIELD. PSYCHOLOGISTS MUST COMPLETE A SPECIFIC NUMBER OF CE CREDITS WITHIN A DESIGNATED PERIOD, TYPICALLY EVERY TWO YEARS.

TYPES OF CONTINUING EDUCATION

CONTINUING EDUCATION CAN TAKE VARIOUS FORMS, INCLUDING:

- WORKSHOPS AND SEMINARS.

- ONLINE COURSES AND WEBINARS.
- PROFESSIONAL CONFERENCES.
- RESEARCH AND SCHOLARLY ACTIVITIES.

BY PARTICIPATING IN CONTINUING EDUCATION, PSYCHOLOGISTS ENHANCE THEIR KNOWLEDGE AND SKILLS, WHICH ULTIMATELY BENEFITS THEIR CLIENTS AND THE BROADER COMMUNITY.

ETHICAL STANDARDS AND GUIDELINES

ETHICS ARE AT THE HEART OF PSYCHOLOGY PRACTICE. THE BOARD OF PSYCHOLOGY IN OREGON HAS ESTABLISHED A SET OF ETHICAL STANDARDS THAT LICENSED PSYCHOLOGISTS ARE EXPECTED TO FOLLOW. THESE GUIDELINES ARE DESIGNED TO PROTECT CLIENTS AND ENSURE THAT PSYCHOLOGISTS PROVIDE COMPETENT AND RESPECTFUL CARE.

CORE ETHICAL PRINCIPLES

SOME OF THE CORE ETHICAL PRINCIPLES INCLUDE:

- CONFIDENTIALITY: PSYCHOLOGISTS MUST PROTECT THE CONFIDENTIALITY OF CLIENT INFORMATION.
- INFORMED CONSENT: CLIENTS SHOULD BE FULLY INFORMED ABOUT THE NATURE AND RISKS OF TREATMENT.
- COMPETENCE: PSYCHOLOGISTS MUST PROVIDE SERVICES WITHIN THE SCOPE OF THEIR TRAINING AND EXPERTISE.
- INTEGRITY: PSYCHOLOGISTS SHOULD ACT WITH HONESTY AND INTEGRITY IN THEIR PROFESSIONAL RELATIONSHIPS.

THESE PRINCIPLES HELP BUILD TRUST BETWEEN PSYCHOLOGISTS AND THEIR CLIENTS, FOSTERING A SAFE ENVIRONMENT FOR THERAPY AND PSYCHOLOGICAL SUPPORT.

COMPLAINT PROCEDURES AND DISCIPLINARY ACTIONS

THE BOARD OF PSYCHOLOGY TAKES COMPLAINTS AGAINST LICENSED PSYCHOLOGISTS SERIOUSLY. INDIVIDUALS WHO BELIEVE THAT A PSYCHOLOGIST HAS ACTED UNETHICALLY OR INCOMPETENTLY CAN FILE A COMPLAINT WITH THE BOARD. THE PROCESS FOR HANDLING COMPLAINTS IS STRUCTURED TO ENSURE FAIRNESS AND THOROUGH INVESTIGATION.

FILING A COMPLAINT

TO FILE A COMPLAINT, INDIVIDUALS MUST SUBMIT A WRITTEN STATEMENT OUTLINING THE CONCERNS, INCLUDING ANY RELEVANT DETAILS OR EVIDENCE. THE BOARD REVIEWS ALL COMPLAINTS AND DETERMINES WHETHER FURTHER INVESTIGATION IS WARRANTED.

INVESTIGATION AND DISCIPLINARY ACTIONS

IF THE BOARD FINDS SUFFICIENT GROUNDS, AN INVESTIGATION WILL BE CONDUCTED. DEPENDING ON THE FINDINGS, DISCIPLINARY ACTIONS MAY RANGE FROM REPRIMANDS TO LICENSE SUSPENSION OR REVOCATION. THE BOARD AIMS TO PROTECT THE PUBLIC AND MAINTAIN THE CREDIBILITY OF THE PSYCHOLOGY PROFESSION THROUGH THESE PROCESSES.

RESOURCES FOR PRACTITIONERS AND THE PUBLIC

THE BOARD OF PSYCHOLOGY PROVIDES VARIOUS RESOURCES FOR BOTH PRACTITIONERS AND THE PUBLIC. THESE RESOURCES HELP ENSURE THAT PSYCHOLOGISTS ARE INFORMED ABOUT THE LATEST STANDARDS AND GUIDELINES, WHILE ALSO ASSISTING THE PUBLIC IN UNDERSTANDING THEIR RIGHTS AND RESOURCES AVAILABLE TO THEM.

THESE RESOURCES CONTRIBUTE TO A WELL-INFORMED COMMUNITY AND PROMOTE A CULTURE OF ACCOUNTABILITY IN MENTAL HEALTH SERVICES.

THE IMPACT OF THE BOARD ON MENTAL HEALTH SERVICES

Q: WHAT IS THE MAIN PURPOSE OF THE BOARD OF PSYCHOLOGY IN OREGON?

A: THE MAIN PURPOSE OF THE BOARD OF PSYCHOLOGY IN OREGON IS TO PROTECT THE PUBLIC BY REGULATING THE PRACTICE OF PSYCHOLOGY, ENSURING THAT LICENSED PSYCHOLOGISTS MEET HIGH STANDARDS OF EDUCATION, ETHICS, AND PROFESSIONAL CONDUCT.

A: THE BOARD OF PSYCHOLOGY PROVIDES RESOURCES SUCH AS INFORMATION ON FINDING LICENSED PSYCHOLOGISTS, GUIDELINES FOR FILING COMPLAINTS, AND EDUCATIONAL MATERIALS ON MENTAL HEALTH SERVICES.

Q: HOW DOES THE BOARD OF PSYCHOLOGY BENEFIT THE MENTAL HEALTH PROFESSION?

A: THE BOARD OF PSYCHOLOGY BENEFITS THE MENTAL HEALTH PROFESSION BY ENSURING THAT PSYCHOLOGISTS ARE QUALIFIED, ETHICAL, AND CONTINUOUSLY EDUCATED, WHICH ENHANCES THE OVERALL QUALITY OF MENTAL HEALTH SERVICES PROVIDED TO THE COMMUNITY.

Q: WHAT IS THE PROCESS FOR OBTAINING A LICENSE TO PRACTICE PSYCHOLOGY IN OREGON?

Q: HOW OFTEN MUST LICENSED PSYCHOLOGISTS COMPLETE CONTINUING EDUCATION?

A: LICENSED PSYCHOLOGISTS IN OREGON MUST COMPLETE CONTINUING EDUCATION CREDITS EVERY TWO YEARS TO KEEP THEIR LICENSE ACTIVE AND MAINTAIN THEIR KNOWLEDGE AND SKILLS IN THE FIELD.
