4. CORRECTIONAL OFFICER

WHILE NOT A TRADITIONAL ROLE FOR SOMEONE WITH A BA IN FORENSIC PSYCHOLOGY, MANY GRADUATES FIND OPPORTUNITIES IN CORRECTIONAL FACILITIES. CORRECTIONAL OFFICERS MONITOR INMATES, ENSURING SAFETY AND SECURITY WITHIN THE INSTITUTION. UNDERSTANDING PSYCHOLOGICAL PRINCIPLES CAN ENHANCE AN OFFICER'S ABILITY TO MANAGE BEHAVIORAL ISSUES AND DE-ESCALATE POTENTIALLY VOLATILE SITUATIONS.

SKILLS AND QUALIFICATIONS NEEDED
