RESEARCH SKILLS

FORENSIC PSYCHOLOGY RELIES HEAVILY ON RESEARCH AND DATA ANALYSIS. PROFESSIONALS IN THIS FIELD MUST BE ADEPT AT CONDUCTING RESEARCH, INTERPRETING DATA, AND STAYING UPDATED ON THE LATEST DEVELOPMENTS AND METHODOLOGIES IN PSYCHOLOGY AND LAW.
