CRIMINAL INVESTIGATOR

FORENSIC SCIENTIST

FORENSIC SCIENTISTS APPLY SCIENTIFIC PRINCIPLES TO ANALYZE PHYSICAL EVIDENCE FROM CRIME SCENES. THEY WORK CLOSELY WITH LAW ENFORCEMENT AGENCIES TO PROVIDE CRUCIAL INFORMATION THAT CAN HELP SOLVE CRIMES. SPECIALIZATIONS WITHIN FORENSIC SCIENCE INCLUDE DNA ANALYSIS, TOXICOLOGY, AND BALLISTICS, AMONG OTHERS.

POLICY ANALYST

POLICY ANALYSTS IN CRIMINOLOGY WORK TO EVALUATE AND DEVELOP POLICIES RELATED TO CRIME PREVENTION AND CRIMINAL JUSTICE REFORM. THEY OFTEN CONDUCT RESEARCH, ANALYZE DATA, AND PROVIDE RECOMMENDATIONS TO GOVERNMENT AGENCIES AND ORGANIZATIONS. THIS ROLE IS CRITICAL FOR SHAPING EFFECTIVE STRATEGIES TO REDUCE CRIME AND IMPROVE COMMUNITY SAFETY.

CAREER PATHS IN PSYCHOLOGY

SIMILAR TO CRIMINOLOGY, PSYCHOLOGY OFFERS A BROAD SPECTRUM OF CAREER OPTIONS THAT CATER TO VARIOUS INTERESTS AND SKILL SETS. CLINICAL PSYCHOLOGISTS PLAY A CRUCIAL ROLE IN HELPING INDIVIDUALS COPE WITH PSYCHOLOGICAL ISSUES, INCLUDING THOSE RELATED TO TRAUMA OR CRIMINAL BEHAVIOR.

FORENSIC PSYCHOLOGIST

FORENSIC PSYCHOLOGISTS APPLY PSYCHOLOGICAL PRINCIPLES WITHIN THE LEGAL SYSTEM, OFTEN ASSESSING THE MENTAL STATE OF DEFENDANTS, PROVIDING EXPERT TESTIMONY IN COURT, AND ASSISTING IN CRIMINAL PROFILING. RESEARCH PSYCHOLOGIST

SCHOOL PSYCHOLOGIST

SCHOOL PSYCHOLOGISTS WORK WITHIN EDUCATIONAL SETTINGS TO SUPPORT THE MENTAL HEALTH AND LEARNING NEEDS OF STUDENTS. THEY ASSESS STUDENTS' PSYCHOLOGICAL NEEDS AND COLLABORATE WITH EDUCATORS AND PARENTS TO CREATE SUPPORTIVE LEARNING ENVIRONMENTS. THIS ROLE IS ESSENTIAL IN IDENTIFYING AT-RISK YOUTH AND PROVIDING NECESSARY INTERVENTIONS.

EDUCATIONAL REQUIREMENTS

RESEARCH AND ANALYTICAL SKILLS

RESEARCH SKILLS ARE NECESSARY FOR GATHERING AND ANALYZING DATA, WHETHER FOR ACADEMIC PURPOSES OR PRACTICAL APPLICATIONS. PROFESSIONALS MUST BE ADEPT AT USING VARIOUS RESEARCH METHODOLOGIES AND STATISTICAL TOOLS TO DRAW MEANINGFUL CONCLUSIONS FROM THEIR WORK.

THE JOB MARKET AND OUTLOOK
