2. CRIMINAL PROFILER

CRIMINAL PROFILERS USE PSYCHOLOGICAL PRINCIPLES TO ANALYZE CRIMINAL BEHAVIOR AND DEVELOP PROFILES OF OFFENDERS. THEY WORK CLOSELY WITH LAW ENFORCEMENT AGENCIES TO IDENTIFY PATTERNS AND MOTIVATIONS BEHIND CRIMES, WHICH CAN AID IN THE APPREHENSION OF SUSPECTS. THIS ROLE REQUIRES STRONG ANALYTICAL SKILLS AND THE ABILITY TO INTERPRET BEHAVIORAL DATA.

3. VICTIM ADVOCATE

5. CORRECTIONAL PSYCHOLOGIST

CORRECTIONAL PSYCHOLOGISTS WORK WITHIN THE PRISON SYSTEM, ASSESSING INMATES AND PROVIDING TREATMENT FOR MENTAL HEALTH ISSUES. THEY PLAY A CRUCIAL ROLE IN REHABILITATION, HELPING INMATES ADDRESS THEIR PSYCHOLOGICAL NEEDS AND REDUCE THE LIKELIHOOD OF REOFFENDING UPON RELEASE.

6. RESEARCHER OR ACADEMIC

FOR THOSE INCLINED TOWARDS RESEARCH, A CAREER IN ACADEMIA OR AS A RESEARCH PSYCHOLOGIST MAY BE SUITABLE. THESE PROFESSIONALS CONDUCT STUDIES ON CRIMINAL BEHAVIOR, LEGAL PROCESSES, AND THE EFFECTIVENESS OF VARIOUS PSYCHOLOGICAL INTERVENTIONS WITHIN THE CRIMINAL JUSTICE SYSTEM.

SKILLS REQUIRED FOR FORENSIC PSYCHOLOGISTS

- **EMPATHY AND EMOTIONAL INTELLIGENCE:** UNDERSTANDING THE EMOTIONAL STATES OF INDIVIDUALS INVOLVED IN LEGAL CASES IS CRUCIAL FOR PROVIDING EFFECTIVE SUPPORT AND ASSESSMENT.
- **RESEARCH SKILLS:** CONDUCTING RESEARCH AND STAYING UPDATED WITH THE LATEST STUDIES IN PSYCHOLOGY AND CRIMINOLOGY IS IMPORTANT FOR EVIDENCE-BASED PRACTICE.
- **CRISIS MANAGEMENT:** THE ABILITY TO REMAIN CALM AND COMPOSED IN HIGH-PRESSURE SITUATIONS CAN GREATLY INFLUENCE OUTCOMES IN FORENSIC SETTINGS.

THESE SKILLS, COMBINED WITH A STRONG EDUCATIONAL BACKGROUND, WILL PREPARE GRADUATES FOR THE CHALLENGES THEY MAY FACE IN VARIOUS ROLES WITHIN FORENSIC PSYCHOLOGY.

EDUCATIONAL PATHWAYS

BACHELOR'S DEGREE

DOCTORAL DEGREE

LICENSURE AND CERTIFICATIONS

3. INFORMING POLICY AND PREVENTION PROGRAMS
